Background

- Lettings for highway projects occur on Thursdays at 10am.
- Lettings for non-highway projects occur on Fridays at 10am.
- Additional letting dates may be added to the schedule as necessary. These special letting dates will be established by the Office of Contract Sales & Estimating.

Guidelines

- Any projects added to the program or deviations from the standard letting process criteria (e.g., 12 Week process instead of 18 Week process) must be approved by the Office of Contract Sales & Estimating prior to programming the project in Ellis.
- Any changes to project letting dates after the lockdown process is completed by the Division of Planning in January of each year must be approved by the Office of Contracts Sales & Estimating.
- Milestones that occur on a weekend or holiday fall back to the previous business day.
- Incomplete or late plan packages may be rescheduled to a future letting.
- Notify DOT CEN Contracts PlanSubmittal, CEN.Contracts.PlanSubmittal@dot.ohio.gov of the plan filing or pre-addenda and DOT Prebid, Prebid@dot.ohio.gov of addenda.
- Do not email any revised sheets to individuals in Office of Contract Sales & Estimating.
- The timeframe to submit pre-addenda is between the "Plan Package Submitted" and "Engineer's Estimate & Funding Deadline" milestones. All pre-addenda must be coordinated with the Office of Contract Sales & Estimating to determine eligibility for submittals.
- The timeframe to submit addenda is between the "Engineer's Estimate & Funding Deadline" and three days prior to the "Letting" milestones. All addenda must be coordinated with a prebid coordinator.
- A project may be delayed to the next scheduled letting if an addendum is issued later than 12pm three business days prior to the scheduled letting.
- If an advertised project is delayed more than once, it will likely be deferred.
- Each year in September, the federal government's accounting system is shut down for fiscal year-end reconciliation. Therefore, adjustments to the letting process milestones will be made and notice of the changes will be sent by the Office of Contract Sales & Estimating to districts as soon as possible.
- All Design-Build projects must be reviewed five weeks prior to submitting plan packages to the Office of Contract Sales & Estimating

Letting Processes

Standard (12 Weeks)

- Federal Exempt or State-Only
- Construction Value < \$10M

Extended (18 Weeks)

- PoDI/PoCI, Federal Exempt, or State-Only
- Construction Value > \$10M
- Prebid Meeting Optional
- All Design-Build Scopes must be reviewed by the Office of Alternative Project Delivery prior to Plan Package Submittal as shown on the Letting Schedules.

Emergency Type A

- File projects as soon as possible.
- Projects will be expeditiously processed by the Office of Contract Sales & Estimating once they are filed.

Emergency Type B, C & Expedited Delivery Projects

- Projects must be coordinated with the Office of Contract Sales & Estimating prior to being filed.
- Projects will be expeditiously processed once they are filed and scheduled in the earliest available letting.

Churned Projects

- Project Churn is any schedule change to the locked program (i.e., added, modified, removed projects).
- The Office of Contract Sales & Estimating manages ODOT-Let project lettings (sales) post-lockdown.
- Do not make any schedule changes for the current fiscal year in Ellis outside of the churn process.
- Do not update Ellis with new letting dates until you receive confirmation from the Office of Contract Sales & Estimating.
- If a proposed sale date is not available, it will not be shown on the form.
- You may continue to request expedited delivery of projects outside of this new process. However, please expedite projects as a last resort (e.g., critical projects that are not considered an emergency).
- All emergency projects are exempt from the churn process and will be expedited on an individual basis.
- Vince Rapp and Natasha Turner in the Division of Planning can assist with questions regarding scheduling in future fiscal years.

State Project Numbers

State project numbers are six digits in length. The first two digits in a Project Number designate the calendar year the project is awarded. The third digit is a coding system as shown in the following table. The last three digits are sequential numbers assigned to each project type. For example, project "200240" means it is the 240th "standard" construction project awarded in 2020.
