**1099.01 Description** This Supplement describes the procedure by which the Department will prequalify Video Detection Systems for inclusion on the Department's Qualified Products List (QPL).

**1099.02 Approval** Submit descriptive literature to the Office of Traffic Engineering that fully describes the system and a manufacturer's letter certifying the system supplied meets or exceeds the requirements of Supplemental Specification 907. Submit proof of previous deployment(s) (minimum six months continuous deployment). Submit a contact name, phone number and e-mail address for each previous deployment. Submit a list of the other States where the system has been approved for use.

The Department will review the submittal and verify the previous deployments. If the system meets the specifications; the product will be added to the Department's QPL.

**1099.03 Removal from the Prequalified List** A Video Detection System shall be removed from the prequalified list if the Department determines the Video Detection System has failed to perform satisfactorily in the field. Experiences of other States and governmental agencies may be considered in this action.

**1099.04 Appeal of Removal** A manufacturer of a removed Video Detection System may appeal the removal under the Department's Qualified Products List Standard Operating Procedure (SOP) – Section H.

**1099.05 Reapproval** A Video Detection System removed from the QPL due to unsatisfactory field performance shall not be returned to the list until the manufacturer identifies the reason for the failure and the problem has been corrected to the satisfaction of the Department. Experiences of other States and governmental agencies may be considered in this action.

**1099.06 Modifications to Prequalified Video Detection Systems** Manufacturers will occasionally modify certain aspects of their products in an effort to enhance performance, improve durability, reduce costs or for other similar reasons. Notify the Department before modifications are made to Video Detection Systems contained on the QPL. Submit descriptive literature of the modification and certify that the modified system meets or exceeds the requirements of Supplemental Specification 907. The Department will review the submittal and determine if the modified system meets the specifications. Modified systems meeting the specifications will be retained on the QPL.

**1099.07 Annual Recertification** By January 1<sup>st</sup> of each calendar year manufacturers will recertify to the Department that the video detection system to be provided meets or exceeds the requirements of Supplemental Specification 907. The Department will not accept modifications (1099.06) with the recertification submittal. Systems not recertified by February 1<sup>st</sup> of each calendar year will be removed from the QPL.
