The fill portion to be done on a daily basis is to just place a wedge of Item 304 - aggregate base at a 3:1 slope from the existing pavement edge down to the stabilized base. Also, place 304 across the stabilized base to provide access to any drives that need to remain open. No equipment is permitted on the stabilized base to place the 304, it must be done from the existing roadway. The 304 placed for drive access is to be traffic compacted, no equipment will be permitted on this. After the five day cure period, the 304 is to be spread out to be used as part of the 4" aggregate base. Material cost for this 304 is included with Item 304 - aggregate base, payment for placing the 304 in this manner is included in Item 206 - cement stabilized subgrade.
