-On plan page 68/84 the general notes for this item state to provide Glass Lenses, however item #3 under this note seems to indicate the use of LED indications. Please specify what is to be used on this project.

Item 633 Controller Unit, Type 170E, w/ Cabinet Type 322, APP

-On plan page 69/84 the general notes for this item does not mention software, and or, prom-module. Seeing that ODOT has the rights to WAPITI the general notes most always state that the prom-module must be shipped to the district office for programming, or, they specify that software MUST be supplied on the contract. Unfortunately, the general notes on this project do not give a clear indication regarding this, please specify if software is or is not to be supplied on this project.
