This guestion is related to Changeable Message Signs PID: 82712.Can a CMS manufacturer which is not listed in the NEVADA QPL but comply with the requirements bid this project?

We will only accept signs which have been reviewed by the Nevada DOT and having been determined to be compliant with their QPL. ODOT will not make the determination of compliance with another state's Qualified Products List, only that state can address their requirements.
