Please provide subgrade elevations for the rock channel protection which is to be installed under the bridge abutments and around the pier. Can an aggregate filter be used in lieu of the filter fabric specified for this reference number?

2. It appears the trees listed for removal in the plans have been removed. There are many trees smaller than 12" that will need removed to construct this project. Can these trees be removed prior to the September 15 Indiana Bat restriction date?
3. Note E on page 25/38 indicates the parapet sealing is included with item 864 for payment. This project doesn't have an item 864.
4. Plan page 27/38 indicates structure patching to extend down well below the river bed to the existing footer. The cofferdam and dewatering necessary for this work is going to be monumental for the quantity of patching involved. Is the cofferdam and dewatering costs for this work to be included with the patching bid item or cofferdam, cribs, and sheeting bid item?
