Project plans require using preformed tape for removal of existing pavement markings that matches the pavement surface as closely as possible. This tape comes only in black and the pavement surface is concrete. Also, blackout tape per the specifications must be replaced every 15 days. As this project will be longer than 15 days may removal of existing lines be performed by waterblasting, shot blasting or sandblasting per 614.11.G.1.a?

As per the "Work Zone Pavement Marking and Signing" note on sheet 4 of 37 of the construction plans, existing conflicting pavement markings shall be covered in accordance with ODOT CMS 614.11.G.1.b. The existing conflicting pavement markings may be removed in accordance with ODOT CMS 614.11.G.1.a only if the Engineer determines there is too much conflict between the tape and the pavement. This determination will be made during construction. Therefore, please bid as per plan.
