As for the drawing reference in the note for "Item 514 - Field Painting, Misc.: Surface Preparation of Existing Steel, Solvent Clean, System OZEU," it is one sheet off; the detail is located on page 13 of the plans.

DOES IT MEAN THE LENGTH OF THE REPAIR, THE LENGTH ACROSS THE WESTBOUND LANES, OR ACROSS THE ENTIRE STRUCTURE? GENERAL NOTE ALSO REFERS YOU TO 8 OF 20. PLEASE CLARIFY WHAT IS ON SHEET 8 OF 20 IN REGARDS TO THE PRECOMPRESSED JOINT SEAL.

The seal is to be installed continuous over the length of the repair. Continuous means uninterrupted or continual. In this case, it means having no joints in the seal over the length of the repair. The details used by the contractor on Sheet 7/20 to obtain the length of repair (8 feet) should have been referred to by the general note instead of Sheet 8/20.
