The clearing and grubbing note on sheet 9/209 indicates that all trees and stumps specifically marked for removal within these plans have been removed as part of a separate contract. Has this work already been performed, or will it be performed by others prior to work beginning on this project? If this is the case, then what is the intent of Ref. 40 Misc. Identification of Bat Habitat Tree? A visit to the site seems to indicate that many of the trees are still there.

A1) The separate clearing contract referred to in the note has already been performed. The primary intent of the previous contract was to clear all large trees/stumps within construction limits to allow utility relocations to move forward. A2) A Clearing and Grubbing pay item and Misc. Identification of Bat Habitat Tree pay item was kept in Proj. 040518 to cover any additional clearing required for roadway construction.
