For item 832 : what erosion control is being asked for here?For landscaping, Pruning of existing shrubs, total 200, does that mean nuber of total bushes to trim? What is 30 " spread? Lanscaping maintenance says unit month with a total of 5 . Does that mean 5 times a month or for 5 months?

Answer 1)a.) Misc. Litter Pickup: Is as described on sheet 3/27. b.) Roadside Cleanup is as described in CMS 656. The conditions include but are not limited to cleanup and removal of tree limbs or vegetative growth that would not be maintained by the mowing.Answer 2)This item and quantity is provided for every maintenance project. An example where it could be used is in the case the contractor disturbs earth, such as in a staging area.Answer 3)The Contractor will be paid for each shrub pruned with an estimated quantity of 200. This only involves shrubs that are not considered to be in a Landscaped area. The 30 " is the avg. width the shrub will be pruned to.Answer 4)5 months - May, June, July, Aug, and September.Each Month will include all 58 Landscaped areas. These areas will be inspected monthly, As long as the areas are not in need of the maintenance items listed on sheet 4/27 or determined to have been neglected, the contractor shall be paid the bid price for 1 month. If a specific area(s) has been determined not to have been properly maintained, the monthly bid price shall be deducted by the increments shown in the table on sheet $4 / 27$.
