The Pedestrian signals are listed as A2 in the summary and the plan note, however, the plan depicts a D2 with a countdown display. Please clarify.

For reference item # 92 - Span Wire Sign Support, Type TC-17.10, Design 5 there appears to be only two (2) supports at station 1481+03 and station 1485+94. Where are the two addition supports at? Also for reference # 100 Removal of Span Wire Sign Support and Foundations it looks like there are 4 poles to be removed and 4 foundations should the pay item be for two (2) each removal for the complete support? There appears to be proposed signage to be installed on new Span Wire Sign Support assemblies but no additional pay item for Sign Hanger Assemblies for the additional 7 signs. Please clarify quantities.

On page 7 of the plans, the 3rd paragraph under "Item 614 Maintaining Traffic", the last sentence states "No work shall be performed throughout the project between the hours of 7:00am to 9:00am and 3:00pm to 6:00pm, Monday through Friday". Does this mean work requiring a lane closure can only happen during this time (9:00am - 3:00pm), or does it mean the contractor can only work 9:00am - 3:00pm regardless of whether or not there is a lane closure or not (meaning the job will be built in 6 hour per day shifts).

What are the detection zone assignments, the system zones are not called out in the chart on page 44

The system detections zones are replacing existing loops and should be set up as the existing loops are.

Are the zones shown at Sta.1480+ on Glendale-Milford to be viewed with a camera on Pole 4?

As stated in ODOT SS 816, the contractor is responsible for providing the correct number of cameras to detect all zones. The notes state that the contractor is responsible for placing the video cameras at appropriate places to see all detection zones. The System detection loops are not associated with any particular camera location.

Please reference the following plan pages: 38/55 item 816 Video Detection System APP, 42/55 detection zones as shown on the plans specificly the system zone (i.e.SD1, SD2, SD3 etc..)44/55 Loop Detector Chart. The plans indicate mounting the cameras on the mast arm, the notes indicate being able to set up the camera to view both intersection and system zones. With a riser supporting the camera 25 to 30 feet may be the maximum height to support a camera properly. Most cameras have a maximum range of about 350 feet. From Pole 4 to SD6,7&8 is approx. 470 feet. Question, 1)are the system zones shown on the plans at Sta 1480+ "video detection zones" or "loops"?

The system detectors are video detection zones.
