2. will there need to be transverse lines and channelizing lines for the ramps?

3. is it really neccessary to spec 446 on this job?

4. please review items 2 (203 excavation) and 6 (301 base). quantities do not seem right. please provide some information and/or details for this work.

1. ref #4 pavement planing, as per plan (heaved joints). are we just suppose to take the tops off? if so, what is ref #5 patching planed surface for? or are we suppose to treat these like a partial depth repair? please provide a detail or more information for this work.

1a. will there be butt joints on the job to grind? (beginning and end of job, ramps)

2. page 29/29 in the plans refers to rpm's being placed 530 each. there is no bid item for this. should there be a bid item for rpm's?

1. On sheets 17 and 18 of project plans it shows reducing the number of westbound lanes from five to three between station 1174+00 and 1182+50. Is this ODOT's intent?

2. Since the plan is moving traffic 8.5 feet to the north, is it the intent of the plans to switch the resurfaced area each night which would mean the Contractor would have to shift traffic mid-way each night to get the proper lane widths or is it the intent to switch WB traffic to the new configuration prior to the resurfacing but after the pavement widening is complete?

3. On sheet 28 it shows the traffic shift will be completed east of station 1348+79.50 but no resurfacing is scheduled east of this station. Traffic will be driving across the rumple strips on the north shoulder since the traffic switch onto the shoulder must be accomplished between the gore @ US 42 and station 1348+79.50. Is this ODOT's intent?

1. No. That was definitely a design oversightand amended sheets are being sent via an addendum. 2. The contract calls for the contractor to submit a Maintenance of Traffic plan for approval. Items such as this would be included. 3. No. A forthcoming addendum has added an item to fill in rumble strips over which traffic will drive.

Question Submitted: 8/1/2006

Since the proposed lane configuration and the existing lane configuration are considerably different, in order to get from the existing lane configuration to the proposed lane configuration, we need some information concerning minumum and maximum allowable temporary lane widths. I believe that a 10 ft temporary minumum width is necessary to make the operation feasible. Also, the plans show how the proposed configuration transitions to the existing configuration at the west end, but at the east end, it just jumps from the existing section to the proposed section. Will the transistion be made on the new pavement or the old pavement?
