QUESTION #5: MOT CONSTRUCTION SEQUENCE PLAN SHT 14 CALLS FOR THE EMBANKMENT NOT TO BE BUILT BETWEEN 36+20 AND 37+90 UNTIL PHASE 5. THIS WOULD REQUIRE THE FORWARD ABUTMENT FILL IN PHASE 1 TO BE BUILT APPROX 100' LONG (AT 35+22 26' HIGH TO 36+20 AT 14' HIGH). THIS IS NOT FEASIBLE, OR WOULD REQUIRE EXTENSIVE TEMPORARY SHEETING TO PROTECT THE EXISITING FACILITY AT 36+20. PLEASE REVIEW.

QUESTION #6: UTILITY NOTES IN THE PROPOSAL STATE ALL UTILITIES TO BE RELOCATED WILL BE COMPLETED BY NOV 1, 2005. ARE THEY COMPLETED AS STATED?

QUESTION #7: PLAN NOTE SHT 11 "CONNECTIONS TO EXISTING MAINS" STATES WATER SERVICE INTERUPTIONS FOR TIE-INS SHALL BE LIMITED TO 6 HOURS BETWEEN 12 (MIDNIGHT) AND 6 AM. PLAN NOTE SHT 11A "CONSTRUCTION NOISE" STATES NO WORK 10 PM & 6 AM. THESE NOTES ARE IN CONFLICT, PLEASE REVIEW.

QUESTION #2:

PLAN SHT 34 & CROSS SECTION SHT 44 HAS A NOTE READING "EX 10" SAN F.M. TO BE ENCASED". HOWEVER, THERE IS NO DETAIL OF THE ENCASEMENT OR BID ITEM FOR THIS WORK. PLEASE REVIEW.

QUESTION #3:

NO "INDIANA BAT" NOTE APPEARS IN THE GENERAL NOTES, THERFORE IT DOES NOT APPLY TO THIS PROJECT. PLEASE REVIEW.
