Page 3/22- Under Scope- The contract was delayed, however, would the District consider extending the completion date to a February 28, 2009 (one year)? Page 5/22- "The contractor shall replace every burned out lamp on the project within thirty days of the contract start up date." Will the contractor utilize reference 2-12 and 15-20 pay items for these repairs? Page 6/22 -Will cleaning and minimal maintenance of structures, only be performed during a repair of a street light that's reported not working properly? There will not be a scheduled cleaning and maintenance of all (entire lighting system) fixtures and structures? Page 6/22 -Will the contractor receive guaranteed monthly minimal maintenance on lighting inventory as in past contracts? Or will the contractor only be paid for the lights they repair? Page 10/22- ITEM 625 – Annual operation and inspection of tower lighting devices, as per plan. The reference item for this task is number 87. The planned quantity is 322 units. Do the 322 units represent 322 tower pole structures? Regardless of how many lights mounted per tower ring, the contractor shall be paid one unit each, for every completed tower structure, whose ring is lowered and inspected? Does the district have 322 tower structures? Does the district plan on inspecting all of the towers during the life of this contract? Does the district have a spare high mast tower lowering machine in case of the original lowering machine needs servicing and/or is not repairable?

Question 1: This question is a result of Addendum # 1. It appears that the minimal maintenance items have been replaced by new luminaire installation. Is it correct to assume that references 3 through 19 are meant to replace all existing luminaires of those types? Question 2: Are the minimal maintenance items being done away with? Question 3: If so, what will be the basis for payment each month?

Answer 1: These references are not to replace the existing luminaires. Answer 2: No. Answer 3: The contractor will be paid for the actual number of fixtures by type that they work on each month.
