The first paragraph of the Clearing and Grubbing note on Sheet 3/22 states "ALTHOUGH THERE ARE NO TREES OR STUMPS SPECIFICALLY MARKED FOR REMOVAL..." However the next paragraph indicates that there are a total of 4 trees to be removed. Which paragraph is correct?

Per CMS 201.01, Clearing and Grubbing consists of removing all vegetation and construction debris from the limits shown on the plans, except such objects that are to be removed according to other items of work. There are a total of 4 trees which are covered by bid line items 0002 and 0003. These trees are marked with an "X" on Plan and Profile sheet 9/22.

The proposal shows a completion date of 8/15/2009.A note on plan sheet 3/22 says "Instream construction activities may not occur from April 16th to June 30th."The contractor will have to work in the stream to erect and remove the formwork. Even if it is possible to complete the first phase prior to April 16th, there is not enough time between June 30th and August 15 to complete the second phase.Will the Department consider extending the completion date?

The completion date does not need to be changed. The project has been issued a Nationwide Permit #3 from the USACE. The waterway permit allows for the use of a "Temporary Work Pad" in the waterway. The contractor must have his temporary work pad in the water prior to April 16. Any work taking place within the waterway must be preformed from the work pad. Construction activities taking place from the work pad are not considered "in-stream" work. The work pad cannot be moved or disturbed until after June 30.
