Page 3/31 of the plans under Item 255 Full Depth Pavement Removal and Rigid Replacement states ... "The Contractor shall saw the pavement 1.5 feet on each side of the joint and completely remove the damaged joint. The pavement shall be replaced per detail shown in these plans" The detail referred to is on page 7/31. Standard drawing BP-2.5 shows a minimum patch width of 6' and includes dowel bars, both of which are in conflict with the note on page 3 and the drawing on page 7. BP-2.5 also states dowel drilling is to be performed with a machine capable of drilling 3 dowels at one time. Gang drilling machines require a minimum of 5' patch width to drill the dowel holes. Please advise whether we are to bid this item following the plan note and drawing or standard drawing BP-2.5

We will issue an addendum to state that BP-2.5 shall be followed rather than the detail on sheet 7 and the notes on sheet 3. This change will increase the 255-10001 - Full Depth Pavement Removal and Rigid Replacement, Class C, as per plan to a total of 5900 SY and the Item 255-20000 - Full Depth Pavement Sawing to 19100 FT.
