Ref. 6- 203 Embankment, Type A: Manufacturer recommends mixture of loam (topsoil) and uniformly graded granular material for this type of material, as to promote free drainage of water as well as to promote grass growth. Recommended amount of topsoil in mix by manufacturer is 23% minimum with 30% optimum. Will ODOT please revisit this specification and determine whether the 203 Embankment, Type A is what is the correct material given no topsoil bid item and requirement of growing grass?

The Dept will not change the Item 203 Embankment, Type A as shown in the plans.

Please refer to plan sheet 2/19, typical section IR-271, and legend item B. Will the contractor be expected to replace the existing 8' bituminous aggregate base shoulder on I-271 if it becomes damaged during work performed under this contract? If so how thick and what type of material will be required?

Yes, the Contractor is required to repair any damage which occurs to this item due to the work performed under this Contract as per the CMS. The repair is to be made using a material that is the same type and thickness as the existing. It is believed that the excising shoulders are made up of approx 6" to 9" of asphalt on top of 6" aggregate base.

Given that the slopes (paved edge to toe drain) will have geotextile fabric below the geoweb slope protection system with granular embankment fill, how will the owner expect grass to grow? Furthermore there is no topsoil bid item. Please clarify what final treatments of slope areas are intended.

The Typical Section is on sheet 2, we assume that you are referring to balloon item 8, not sheet 8. The final treatment is to be as shown in the plans.
