With respect to the prebid question concerning bridge mounted PCB will the department make available the detail as to which the PCB may be anchored to the existing asphalt shoulder? Is the departments idea of potentially using bridge mounted PCB allowable per all applicable standards? Who would assume liability for an accident if PCB anchored to asphalt fails? Also, the asphalt shoulders in the repair areas call out to be replaced. Given the current traffic patterns on the website, the plan note on page 6 that states to place the PCB a minimum 2 feet in from the edge line would the department consider allowing a single lane closure with standard PCB for this area and change the item to 32" PCB?

1. Ref. 8 Gran. Mat. Type E, APP, NO. 2 includes topsoil in the material mixture. You also have a topsoil item (Ref. 25). Is the topsoil doubled up or is it ODOT's intent to install a layer of topsoil ontop of the Gran. Mat. Type E, APP, NO.2? Please Clarify.
