We have received quotations from subcontractors for the diamond grinding of portland cement concrete pavement. They have the following concerns.

1. Grinding cannont be performed within 2' of curb or other vertical obstructions

2. Due to the condition of the existing pavement the ride requirements as indicated in the grinding specification cannot be met. How will ODOT deal with these issues.

I have several questions concerning the Dowel Retrofits on the above referenced project:

1) The concrete pavement is in very bad condition, with large potholes at most of the cracks. what happens when these dowel locations are in a pothole? Is the contractor responsible for repairing the pothole with the patch material?

2) The specifications require a gang saw to saw three dowels at a time. These gang type saws are a special item and will elliminate alot of the competition. with the small amount of dowels required would ODOT approve other methods.

3) Are these dowels to be installed before or after the diamond grinding.

Question 1) Item 255 - FULL DEPTH PAVEMENT REMOVAL AND RIGID REPLACEMENT, CLASS "C" IS SET UP IN THE PLAN TO REPAIR THE POTHOLES AT THE JOINTS. Question 2) FOLLOW THE SPECIFICATIONS. Question 3) DISTRICT 4 DOES NOT HAVE A PREFERENCE AS LONG AS ITEM 257 - DIAMOND GRINDING PORTLAND CEMENT CONCRETE PAVEMENT SPECIFICATION IS MET.
