For item 840 reference 121 mechanically stabilized earth wall will wall panels larger than the 5' x 5' per the spec be allowed?

Will SIP forms be allowed on the bridge deck? Reference number 104 steel piles, mixc.: HP14x89 for temporary shoring is being bid as a 507 item which constitutes permanent piling. If this specification is correct, it appears as if this should be bid as a special or an as per plan, and/or should there be line items for furnish and install. Other questions pertaining to this item are: can the HP be removed after use, does new piling have to be used, and will a foreign product be acceptable?

On page 107 of 127 in the MSE Wall Details, on section A-A, it is ambiguous as to how the material in the second level of hatched area labled as Select Granular Backfill, Item 304 Gradation is to be payed for. Is this material included in the 15809 CY quantity for Select Granular Backfill under Item 840 or is this the material that Note 4 on the same page refers to. I take it that Note 4 refers to the 6" layer of 304 along the concrete coping below the bridge deck and not the material in question. If you could clarify where this material as well as the geotextile fabric is to be paid for whenever you can it would be appreciated. Thanks

Dur to thr time of the year this contract is selling, no work will begin on the embankment construction for the temporary road until May 1, 2008. This work must be completed prior to the construction of the embankment for the bridge fill which can not begin until the temporary sheeting and beam & lagging is completed. This will take approximately 2-3 months to complete. Add in the 45 day waiting period before bridge construction begins and we are already beyound the contract completion date. A more realistic date would be 7/31/09.

Addendum #1 contains numerous questions from bidders concerning the completion date of the project while ODOT addresses the concern by changing the contract completion by 2 weeks until 8/15/2008. This date is still totally unrealistic when one truly comprehends the total scope of the project and the time of year that the project will be starting. By our estimated aggressive schedule a contractor will be lucky to complete both retaining walls, embankment, MSE walls, and possibly the bridge by next December, leaving for 2009 the concrete pavement, traffic switch, existing pavement demolition, and final phase earthwork. This combined with the existing soil conditions (as evidenced by the suggested 45 day settlement which was waived) and the 90' pile length, the best move would be to allow the existing soil to settle and consolidate properly before paving. Please reconsider what other contractors have stated as a reasonable completion date of 7/31/2009. Thanks.

This topic has been discussed extensively by District 6. They were asked again, in light of this latest question, and they feel the current completion date is appropriate.
