There seems to be a discrepancy on page 51 of 55 for bid reference 0040 – Luminaire, Decorative, APP. Under the plan notes, it states that the luminaires shall be a 175 Watt Metal Halide lamp source; however, the Luminaire Schedule chart indicates that the luminaires shall be 150 High Pressure Sodium. Can you clarify the correct lamp source that is required for this project? Thank you.

Page 2/55 shows expansion joint between the existing walk and the new stamped concrete, and also between the existing or new curb and gutter and the stamped concrete. Should this expansion get sealed to prevent water damage and maintenance issues? If so what type of sealer will be required? What color will be required in the stamped concrete? Will the use of colored antique release agent be required or will we be using liquid release agent (no color) for the stamping process?

a: Item 608 does not require the sealing of said expansion joint.a. Bricka: Colored antique release agent is not required.
