The completion date specified for the project is not possible. Structure work is not permitted to start until June 12th. The road must be open to traffic within 45 calendar days. Final completion is scheduled for August 15, 2006. ODOT's schedule does not appear to account for the bearing procurement (10-12 weeks upon order) or bridge painting. This project will require shift work and overtime to complete within the 45 day closure. Please review.

Plan sheet 10-12/34 shows the existing median in the roadway area to be removed. The typical section on plan sheet 2/34 also indicates the median removal as well but the details are unclear. Does the median get removed full depth or partial removed for the asphalt overlay?

There is an existing structure mounted extrusheet sign on the west railing over the southbound IR-475 travel lanes. The sign and support must get removed and replaced due to the bridge parapet replacement. This work was not addressed in the plans and therefore no pay items are included.

Plan sheet 21/34 show the existing power poles and pull boxes along the east side of the bridge to remain. These items are within 6' of the existing wingwall which must removed and replaced. Excavation for new footings and wingwalls will undermine the poles. Since no utility notes are provided in the proposal, will the affected utility shore the poles during construction?

IN TALKING TO BEARING MANUFACTURERS THEY ARE TELLING US BEARING DELIVERY IS OUT 12-14 WEEKS FROM ORDER. IF WE ORDER THE BEARING THE DAY OF THE LETTING (MAY 3) THE BEARINGS WOULDN'T GET THER TILL JULY 26TH AT THE EARLIEST. AFTER THAT WE HAVE ALL THE RECONSTRUCTION WORK TO DO ON THE BRIDGE WHICH IS ANOTHER 30 DAYS+ OR-.THIS PUTS US INTO THE END OF AUGUST AT THE EARLIEST BEFORE THE BRIDGE CAN BE REOPENED TO TRAFFIC. YOU ONLY EXTENDED THE COMPLETION DATE FOR PAINTING TO SEPT. 15, 2006 WHICH GIVES THE PAINTER LESS THAN 15 DAYS TO PAINT THE STRUCTURE AND THE GENERAL TO CLEAN UP THE SITE BY THE SEPT. 15 DATE.HOW SHOULD WE ADDRESS THE OVERRUN IN TIME NEEDED FOR THE CLOSURE OF THE BRIDGE ANF D THE EXTENSION OF THE FINAL COMPLETION DATE??

The District Bridge Engineer contacted a manufacturer and was told that the bearings could be fast tracked on a 8 to 10 week turn around. This would make the August 15 date feasible.
