MAJOR BRIDGE POLICY

POLICY STATEMENT:

This policy establishes the need for a funding source separate from the general system bridge allocation for major bridges owned by the state, i.e., the route carried is an Interstate highway, U.S. numbered highway or state highway. It also provides the definition of major bridges and guidelines for the use of major bridge funds.

Since the Major Bridge Program was established to address high cost bridge rehabilitations or replacements, projects on bridges eligible under the program with an estimated construction cost less than \$1,000,000 will generally not be considered for major bridge funding. The preliminary engineering, right-of-way and construction phases of an approved project will be eligible for major bridge funds. However, the program will not fund routine maintenance inspection contracts. Construction inspection by consultants for major bridge projects may be funded with the approval of the Major Bridge Program Manager. Projects initiated by neighboring states for Ohio River structures will receive major bridge funds for work that is not maintenance in nature, i.e., a separate agreement with that state will be required.

Projects utilizing major bridge funds may be delivered and sold by ODOT conventionally or in the design-build program. Major bridge funds will not be used for Local Let projects administered and sold by local agencies.

The allocation for the Major Bridge Program will be established by the Funds Management Committee on the basis of major bridge conditions.

The Major Bridge Program Manager will be responsible for the development and maintenance of a thirty-year asset management plan for all major bridges owned by Ohio. The asset management plan will outline a schedule for inspections, routine and preventive maintenance, rehabilitation/replacement, etc.

SCOPE:

This policy is applicable to the Divisions of Planning, Production Management and Highway Operations, as well as all Districts.

BACKGROUND AND PURPOSE:

In Fiscal Year 1996 ODOT developed a process to allocate bridge funding to each District. The allocations were based on a formula which included the District's bridge inventory, deck areas, condition ratings and other factors.

An immediate concern of the Districts was their ability to fund high cost bridge rehabilitations or replacements. The rehabilitation or replacement of a major structure could consume a District's entire bridge allocation for a given year and leave them unable to maintain or improve their general system bridge conditions. For this reason the decision was made to define major bridges and fund them separately from the District bridge allocation to ensure their preservation and diminish the impact on the District's program.

DEFINITIONS:

Major Bridge

Meets one or more of the following criteria:

- A. More than 1000 feet in length
- B. Single bridge with a deck area of 81,000 square feet (9000 square yards) or greater
- C. Twin bridges with a deck area of 135,000 square feet (15,000 square yards) or greater
- D. Spans the Ohio River
- E. Moveable bridge
- F. Continuous/cantilever truss bridge
- G. Suspension bridge

The list of structures owned by Ohio that currently satisfy the major bridge criteria is attached as Appendix A. A list of Ohio River crossings that are owned by Kentucky or West Virginia and are potential candidates for major bridge funds is attached as Appendix B.

TRAINING:

None required.

FISCAL ANALYSIS:

Implementation of this policy will have no additional fiscal impact to ODOT.
