Please clarify. Thank you,

If site excavations do not yield enough material to construct the rock embankment, will the remaining portion of the rock embankment area be constructed with #203 embankment? Site rock from excavations may be used to construct rock embankments provided it meets the specifications as per Item 203. Item 203 embankment will not be permitted in locations where the plans specifically call for the placement of rock. If there is not enough rock available on site then the contractor will be required to import the rock embankment.
