Some of the consulting engineering firms looking at providing the Independent Quality Firm (IQF) services have expressed concern regarding some of the broad language to describe the duties and responsibilities of the IQF. The objection is to the broad language, as opposed to the described services, which can expose firms to lawsuits, which are very expensive to defend and, on occasion, settle although they have either little or no control over the incident leading to the claim. The issues of concern include: (1) Authority to Stop Work; (2) Responsibility for the Quality of Construction or Design; (3) Language Implying Guarantees or Warranties; (4) Lack of Definition of "Over the Shoulder" Design ReviewI.AUTHORITY TO STOP WORK The Scope of Work gives the IQF the authority to stop work in the following sections: Sec. 2.2 Independent Quality Firm (page PS-29) "The IQF will: ... B.... "The IQF will have the authority to stop all design work and construction work if all quality requirements are not being met, exclusive of schedule or cost;" Sec. 2.4.2 (page PS-32) "The IQF will have the authority from the DBT to reject design work, "stop construction work," and "reject material" if quality requirements are not being met, exclusive of schedule or cost."Reason for Concern: The language in the Quality Management Scope of Work, which gives the authority to stop work to the IQF firm creates substantial legal exposure to the IQF. Having the right to stop work can be and is often construed as the having the duty to stop work. If the IQF has the duty to stop work because of a quality issue, courts have also found that they have a duty to stop the work if jobsite safety is in question. Juries have imposed million dollar verdicts against engineer/inspectors for jobsite injuries when there is contract language that is used to impose responsibility for safety on on-site engineers even though others created the unsafe conditions. Additionally, the Secretary of Labor, through OSHA, seeks to impose substantial and uninsurable fines on engineers providing on-site services for construction site injuries using the right to stop work as a rationale. Jobsite safety normally - and rightly - is the primary responsibility of the general contractor, who has the actual physical control of its employees and of the site. The Scope of Work for the IQF should not include language that can unintentionally broaden the duties and exposure of the IQF to liability when the intended result can be achieved by amending the language. Additionally, we seek clarification of the intent of the phrase "exclusive of schedule or cost." It appears that this language seeks to emphasize the independence of the IQF and that the owner, design builder or designer would not have recourse to seek costs or damages for delay against the IQF in the event the IQF stops design or construction for quality reasons, however, this concept could be presented in a much clearer manner. Suggested Revision:

B.... The IQF will have the authority to reject (or recommend rejection to the Engineer) any design or construction work if, in the judgment of the IQF, the quality requirements in the Quality Management Plan are not being met. Neither this authority nor the IQF's good faith judgment to reject or not reject any work shall subject the IQF to any liability or cause of action to any third party, including any entity or person performing work on the Project. II.RESPONSIBILITY FOR THE QUALITY OF CONSTRUCTION OR DESIGNThe Scope of Work makes the IQF responsible for the quality of the design and/or construction in the following sections: Sec. 2.2 Independent Quality Firm (page PS-29) The IQF will be responsible for providing qualified personnel and ensuring that the Project quality requirements are met." Sec. 2.6.1.2 (page PS-37) Independent Construction Quality Manager. "The QMP will name the Independent Construction Quality Manager, who will be responsible for the quality of the construction elements of the Project." Sec. 2.6.1.3 (page PS-37) Independent Design Quality Manager. "The QMP will name the Independent Design Quality Manger, who will be responsible for the guality of the design elements of the Project." Sec. 2.6.1.7 (page PS-39) Other IQF Staff Responsibilities. "The QMF inspection staff and geotechnical and environmental monitors will check for compliance with all permits, environmental monitoring and construction operations." Reason for Concern: The duties of the Design Build Team are generally defined well in the Scope of Work, including that the Designer are responsible for the design, the Contractor is responsible for construction and the IQF is responsible for observing, auditing and verifying the designer and contractor's compliance with the Quality Management Plan. By making broad statements like the IQF will be responsible for the guality of the construction elements, the lines of responsibility are blurred and can be used by third parties to seek compensation from the IQF for issues that are not their responsibility. "The QMP will name the Independent Construction Quality Manger, who will be responsible for monitoring (or auditing) the quality of the construction elements of the Project." Sec. 2.6.1.2 (page PS-37) Independent Design Quality Manager. "The QMP will name the Independent Design Quality Manger, who will be responsible for monitoring (or auditing) the quality of the design elements of the Project." Sec. 2.6.1.7 (page PS-39) Other IQF Staff Responsibilities. "The QMF inspection staff and geotechnical and environmental monitors will check for compliance with all permits, environmental monitoring and construction operations in accordance with the Quality Management Plan." III LANGUAGE IMPLYING GUARANTEES OR WARRANTIES The Scope of Work includes statements that imply that the IQF is guaranteeing the quality of all the design services and/or construction work in the following sections: Sec. 2.6.2(page PS-41) QMP Section 2 - Administration Requirements. "In general, QMP Section 2 (Administration) will describe the procedures for coordinating and ensuring the consistency and quality of all Work performed or provided for the Project by all participants." The IQF Manager will ensure that each deficiency has been corrected before the agreed completion date."Sec. 2.6.4.6 (page PS-49) DBT's IQF review. "The Independent Design Quality Manager will review all designs to ensure that development of the Plans and Specifications are in accordance with the requirements of the Contract."Sec. 2.6.4.9 (page PS-50) Interim and Final Reviews. Reason for Concern:By using "language of guaranty or warranty," such as "ensure," "insure," "certify"or "assure," the Scope of Work can create the basis for a guarantee claim against an engineer, meaning that the engineer is guaranteeing that something is perfect or unequivocally true. Each design and construction project is one of a kind and it is too expensive for all parties involved in design to create and test prototypes of all the design and construction elements to guarantee that a design is perfect. Although the IQF will diligently follow and enforce the quality requirements in accordance with the QMP, there can be no guarantee that each and every coordination issue or defect can be detected. Although engineers carry professional liability

The Proposal contains a section on ODOT CMS 109.05.D.2.e (1), Field Overhead. The section includes a replacement for Table 109.05-5 of the 2008 ODOT C&MS. The revised table reduces the maximum Home Office Overhead percentage "C" to be used with the original contract amount from 0.05 to 0.025. We request that Table 109.05-5 remain unchanged as it stands in the current C&MS. Our opinion is that the large design-build jobs take more home office effort and involvement than the typical smaller project and the perceived economies of scale of these large design-build projects do not exist. While in the DBT's that are a joint venture of two or more companies one of the partners will be named the administrative manager, all the team members provide services to the joint venture that require as much or more than a series of two to four typical \$50M projects.

The Department does not believe an appropriate Home Office Overhead percentage for this project should be the same as a an over \$25 million project, bid as per the proposal.
