**A1) The plan note on sheet 4/5 identifies this material as "bagged litter". This is an accurate description. The material generally consists of bagged litter from prison litter crews and "Adopt-a-Highway" organizations who pick up litter along the interstate highways in Cuyahoga County. It is the responsibility of the contractor to determine if "bagged litter" is sanitary or C & D. A2) The plan note on sheet 3/5, paragraph 1, for this item generally defines "road debris". There are over 14 typical types of debris listed in this definition. It is the responsibility of the contractor to determine if this "road debris" is sanitary or C & D. A3) The ODOT Cuyahoga County maintenance yards are not regulated, by the EPA, at this time. A4) Estimated plan quantities have been provided. It is the responsibility of the contractor to bid the items accordingly. A5) The sweeper waste is listed as one of several types of "road debris" accumulated at the maintenance yards. It is up to the contractor to determine if the "road debris" is considered or classified sanitary or C & D.**
