Q1) ADDENDA NO. 2 STATES THAT THE OVERLAYS FOR THREE STRUCTURES, CUY-043R-0607, GEA-422R-1226, AND LAK-020R-1723, ARE TO BE PERFORMED ON THE WEEKEND. MAINTENANCE OF TRAFFIC NOTES STATE TO FOLLOW THE D12 PERMITTED LANE CLOSURE TIMES. NONE OF THE FIVE OVERLAY STRUCTURES FALL UNDER THE D12 PERMITTED LANE CLOSURE TIMES. PLAN NOTE STATES THAT ANY ROADWAY NOT LISTED SHALL HAVE NO CLOSURES ON WEEKDAYS FROM 7AM - 9AM AND 3PM - 6PM. YOU CANNOT PERFORM THESE OVERLAYS UNDER A 13-HOUR NIGHTLY CLOSURE. THEREFORE, IS IT CORRECT TO ASSUME THAT WE CAN CLOSE TRAVEL LANES FOR THE WEEKEND OVERLAYS FROM 6PM FRIDAY TO 7AM MONDAY? ALSO, IF YOU CAN ONLY HAVE NIGHTLY LANE CLOSURES DURING THE WEEK FOR THE OTHER TWO OVERLAY STRUCTURES, CUY-014D-0015 AND CUY-014R-0538, WOULD YOU NOT HAVE TO PERFORM THESE STRUCTURES ON THE WEEKEND AS WELL? THIS IS A CONTRACTOR DESIGN MOT PROJECT, BUT WE HAVE TO KNOW WHAT WORK WINDOWS WILL BE REQUIRED. PLAN DOCUMENTS DO NOT CLARIFY THESE ISSUES. PLEASE ADDRESS.Q2) ADDENDUM NO. 2 NOTES ADDED PROVISIONS FOR EMERGENCY ASPHALT PAVING OPERATION ON STANDBY. NO BID ITEM WAS ADDED TO THE EBS FILE. PLEASE CLARIFY.Q3) ADDENDUM NO. 2 ADJUSTED QUANTITIES FOR THE HYDRODEMOLITION ITEM, BUT NO ADJUSTMENTS WERE MADE TO THE WEARING COURSE REMOVAL ITEM. SHOULD THIS BE ADJUSTED AS WELL?
