When can this work be performed? The plan notes state No Lane Closures permitted until June 1, 2008. Every pier under bridge has a steel nose plate on the face of each pier. This steel is difficult to contain for lead paint removal and is not addressed in plans or specs. Are these areas to be blasted SP10 and OZEU system?

The falsework is to be removed this spring by the contractor that preformed the deck replacement. The steel on the nose of the pier is not considered structural and is not to be painted.
