Due to the large dollar amounts of asphalt and electrical work on this project we are requesting to reduce the amount of work performed by the prime contract as listed in 108.01 from 50% to 35%.

Page 18/410 of the plans has note regarding Managing Petroleum Contaminated Soils in which dewatering is mentioned in paragraph #8. Please note there is no biditem for work involving water or work involving regulated water.

1. The plans state: "steady-burning type C lights shall be required on all barricades, drums and similar traffic control devices (see sheet 19)". ODOT 614 specification does not require the use of type c lights on drums. The maintenance of traffic items is not bid as per plan. How are we to be compensated for this.2. Plan sheet 19 in the middle column last paragraph states: "the contractor shall provide 1 law enforcement officer for the purpose of controlling traffic at/on Hilliard Rome Road and Roberts Road between the hours of 7:00 a.m. and 6:00 p.m." Addendum 1 revises the overall project completion date to be August 30, 2009. For the contractors to include a policeman for the duration of the project would be a considerable amount of money (\$47/hr*11hr/day*7day/week(?)*121weeks(?) = \$437,899(?)). We are recommending an allowance pay item be established to compensate then contractor for this policeman.3. Since addendum 1 revised the overall project completion date to August 30, 2009, we are recommending that you revisit the 20 month duration for the field office (bid reference 302).

The maintenance of traffic plan sheets 20 and 21 call for the majority of the side roads to be constructed one at a time (See phase 1 item 11 and phase 2 item 4) or half width (see phase 1 item 12 and phase 2 item 5). Constructing these side roads in this manner will add a significant number of mobilizations for the lime stabilization and asphalt paving crews which will add a significant amount of time and money to the project. We are suggesting that you review these restrictions to determine if they are absolutely necessary and minimize them if at all possible. At a minimum, we are suggesting that the ODOT establish quantities of undercut and stone backfill at these intersections to reduce the number of mobilizations and cure time for the lime stabilization.
