Bid Ref, #0500 is written as, "NO. 4 AWG DISTRIBUTION CABLE, AS PER PLAN". A quantity of 1326 LF is given. The AS PER PLAN note refers to MIS-14 from the Street Lighting and Installation Specifications from the City of Columbus. This specification speaks in terms of circuit feet, which consists of multiple wire conductors, resulting in a much larger quantity than the LF bid quantity. Will payment be made on a LF basis at roughly double the current bid quantity, or will the basis of payment be changed to reflect "Circuit Feet" to match the MIS?
