In addition to, the structure deducts are actually being added to the total and do not reflect the quantities spelled out on Sheet 32 of 40. Please provide the appropriate data necessary to bid the Tack Coat, Surface Course, and Pavement Planing items accordingly.

In Addendum No. 2, the Railing Faced, APP Item was removed from the proposal and Patching Concrete Structures was added. Is it still the intent to construct Parapet Walls in the Concrete Barrier, Single Slope, Type A location? And if so, is this work incidental to the newly added Patching Concrete Structures item?

Sheet 32 of 40 lists Item 446 - Asphalt Concrete Surface Course, Type 1H and Sheet 11 of 40 lists Item 442- Asphalt Concrete Surface Course, 12.5 MM, Type A (446). Should this be Item 442 - Asphalt Concrete Surface Course, 12.5 MM, Type A (446)(on Sheet 32 of 40).

# Question Submitted: 11/23/2005

Sheet 16 of 40 shows the use of Item 302 material in both the 251 Partial Depth Pavement Repair and 253 Pavement Repair items. Sheet 4 of 40 indicates the expectation that Item 301 will be used in the 253 Pavement Repair item. This needs to be clarified.

If Item 302 is the material you intend to specify, we are concerned with the use of 302 for either of the 251 and 253 items. Considering the time of year and traffic, the use of 302 may cause some rideability and raveling issues in the time that transpires between the repairs and the 1.5" mill and fill. We feel you should consider clarifying this item by specifying a material no courser than a 301 material.

We look forward to your response on this matter. Thank you.
