Question#1: After reviewing the plan notes and spec restrictions involving the seeding, tree and shrub plantings, and the Bald Eagles; we don't find the completion date to be viable. When all of the items of work and the restricted issues are combined and compared to each other in a rough progress schedule, the project cannot be completed within the specified time frame. Question#2: Additionally, it may be impossible to attain the 7% DBE goal considering the items of work included in this project. Please review.

Item 690 Special- Misc: Grading As Per Wetland Specialist is listed in the General Summary as a Lump Sum while the note describing the work on sheet 5 of the plans lists it as a unit bid with an estimate of 8 total units. It appears the General Summary is in error. Secondly, how is the contractor supposed to bid this item without knowing what piece of equipment will be used as directed by the Wetland Specialist? This is too open and too general to put a unit price on it, let alone the Lump Sum shown in the General Summary. Finally, each unit is described as 4 hours of grading. For the purpose of simplicity and the elimination of any dispute involving when the next unit is paid when a partial unit is performed, it would be far easier to make each unit equal to one hour of grading similar to what is done for hours of Proof Rolling under Item 204 in the ODOT spec book.

Is it a plastic netting held in place with wire staples, a chemical tackifier, a combination of a chemical tackifier and fibers, or some other product? Please provide a more clear description. Question 2: On drawing 7 Item 659 Seeding Misc.: Seed Oats does not mention if straw mulch is required. If it is required, is it paid as reference 0034 Straw Mulch? Question 3: On drawing 7 do the Items 661 Tree Seedling, As Per Plan; Deciduous Shrub, As Per Plan; and Deciduous Tree, As Per Plan(1" Caliper); listed under Basis of Payment completely replace Item 661 of ODOT C&MS 2008, or is C&MS 2008 to be used whenever the plans do not specifically change the sections and requirements of C&MS 2008?

The WETLAND SITE PW-A on page 23 needs to be cleared, excavated, place tied concrete block mat, seeded with scrub emergent, planted with shrub, and cared for thourgh one growing season.
