On plan sheet 5/30 under the note for Designated Local Detour Route, quantities have been designated for maintaining the local detour route and upon completion of the project, to restore the route to a condition that is equivalent to that which existed prior to its use for this purpose. Peach Orchard is a chip & seal road and Union Road is gravel. With the type of items and the large quantities (480 Cys of 448 Asphalt) that have been designated to maintain and restore these roads, is it ODOT's intent to place asphalt on the chip & seal and gravel roads? Is the County/Township expecting something more than equivalent?

1.) Would ODOT review & revise the two demo notes on page 14 of 30 to allow the contractor to be allowed to use hoe rams on the existing deck removal and for the abutments only. Since the deck and the abutments are being completely removed and not saving the existing structural steel. If the piling would happen to get damage then the contractor would fix at his own cost, all we are doing is adding additional cost to this bid for no real purpose! The existing notes should only apply to the demo of the existing piers since they are being retrofitted.2.) Should there be a bid item for cofferdams since we are widing the existing pier footers?

### Question Submitted: 3/24/2009

Why do the plans call for Pressure Relief Joint type A when the typical sections show the existing pavement is asphalt? Pressure Relief Joint type A is normally used with rigid pavement/base.

The proposed structure is designed with a integral abutment and to help accommodate for the movement of the structure, including the approach slab, a pressure relief joint type A shall be placed at the ends of the approach slabs. Although typical sections show asphalt, pavement details (sheet 3/30) shows the pressure relief joint type A and the limits of the asphalt overlay.
