We were notified that we were qualified and that there would be a teleconference the week of Feb 22, but have not received a notice or time for this teleconference. Is this still to occur and is the bid due date still March 11, 2010, and the question due date still March 4, 2010?

Question Number: 6

The Treatment Unit is described as comprising 150-gallon tanks in Section 3.3.1 of the Remedial Plan Implementation. Is it acceptable to use tanks of a different volume? The Treatment Unit is also described as using chemically resistant inline electronic flow meters. Assuming the flow rate can be measured in another manner, is it a requirement to use such a flow meter?

Yes, it is acceptable to use tanks of a different volume. Another manner of measuring flow rate is acceptable providing the rate can be accurately measured.

Question Number: 7

Will water be available? If so, where is access? What flow rate will likely be available? What size of connection is it? Will electricity be available? If so, where is access? Can chemicals and equipment be stored on site, and if so, is it indoors or outdoors? Will it be secure? How much space is available?

It will be necessary for the contractor to provide water for the operation. The contractor must also provide power/ electricity for the operation. The grounds at the site are fenced and locked but there is no inside storage available.
