Questions pertain to Part 2 (Construction of new turn lane on southbound Reynolds Rd)1. How do we get paid for the removal of existing pavement and excavation necessary for the construction of the new concrete median?2. How do we get paid for the excavation required to construct the new turn lane? It seems that a quantity has not been established correctly.3. The General Summary on Plan Sheet 8 of 24 refers us to Plan Sheet 5 for 243 cy of Excavation. The Subgrade Undercutting note on Sheet 5 says that all 243 cy of Excavation is for subgrade undercutting. Please review this issue.

1. Please review the note for "Sprinkler Systems" as found on Plan Sheet 5 of 24 (PART 2) of this project, and please refer to the "Conduit for Sprinkler Systems" and "Sprinkler Heads" bid items. A. According to the note, this provision only applies to sprinkler systems parallel to and within 30 inches of the back of curb removed. How does that apply here, when we're constructing a new turn lane and pushing the curb back 12'? B. In the 4th paragraph, why should the contractor be responsible for sprinkler heads not marked by the property owner? C. When do we use the "Conduit" and "Sprinkler Head" pay items, whenever we encounter these, or only when they're within 30" of back of curb, or otherwise? D. I believe this is a "boilerplate" general note that Toledo uses for sprinkler systems in curb removal and replacement situatiuons, but may need to be tailored to fit this project.2.See Plan Sheet 13 of 24 (Part 2). At Sta 12+41.97 Lt, the contractor is to install a Ty 3 CB. Is that to be doghoused on an existing sewer? Is that the terminus of the pipe? Is there an existing structure to be removed at that location?
