Question #1 This project is an 881 Micro Surfacing job. The plan sheets indicate Butt Joints at intersection approaches. Butt Joints are not applicable to Micro Surfacing. A clarification of the term "Butt Joint" is needed. Question #2 The traffic concerns should be many on this project. No plan notes regarding traffic maintenance outside of LEO's are included on Pg.33.

On page 33 of the notes discusses Item 614. Nowhere in the notes does it mention about lane closures or time restrictions that are allowed on each road. What are the specific traffic requirements for each location? On the plan sheets it indicates that butt joints are required at intersection approaches and at beginning and ending limits of each road. Butt joints are not required on microsurfacing and would not be applicable. What is the intent of the butt joint. Need clarification on this item.
