#### Question Submitted: 2/15/2010

This project has a bid item Pavement For Maintaining Traffic Class A by the SY. Should a bid item be added, 615 Roads for Maintaining Traffic, Lump Sum to cover all the associated road work not included in the square yard bid item.

### Payment for Pavement for Maintaining Traffic Class A includes all items of work necessary to construct the temporary pavement to the dimensions shown in the plans. Therefore there is no need to add 615 Roads for Maintaining Traffic, Lump Sum.

# Question Submitted: 2/23/2010

Supplemental spec 848.24 describes containing, collecting and disposing of the waste from the secondary surface preparation prior to overlay with the same restrictions as the hydro-demolition waste when water blasting in employed. Are these same handling/ disposal techniques required if only dry blasting surface preparation methods are used?

#### Question Submitted: 2/23/2010

Plan Sheet 3/48 only indicates pavement removed applicable to the concrete section of South Bound US 23. The corresponding quantity does not represent the bid quantity. Is it the Departments intent to pay for the concrete ramp D section and all the asphalt shoulder areas under this item also?

Per Pavement Subsummary table on sheet 28 of 49, the pavement removed quantities includes the southbound US 23 and Ramp D. The shoulders are also included.

# Question Submitted: 2/23/2010

There is no wearing course removal item for the approach roadway asphalt or asphalt wearing course on the existing concrete approach slabs. How/Where will the Department pay for this work?

The asphalt removal is included in 202 Pavement Removed as per CMS 202.05.
