The previous specification 401.20 Asphalt Binder Price Adjustment in the 2008 Spec book defined the bidding index as the asphalt index in the month immediately before the month the project is bid. This specification allows the contractor to know the actual index which reduces the risk involved in the binder pricing at the time of the bid. Please consider changing the definition of the Bidding Index to the Asphalt Index for the month before the project is bid.

The Bidding Index shall be as defined in PN 530.
