Based on the area shown on sheet 26 (160 SY) and the 4" thickness this equals 18 CY not SY. The Proposal and General Summary has 18 "SY". Please verify units and quantity desired.

Reference 30 Pavement Repair APP note on sheet 10/52, top of center column, calls for the replacement surface material to be 448 type 1 PG64-22 as detailed on sheet 7/52. The Pavement Repair detail on sheet 7/52 refers to type 1H material for the surface. Please verify type 1 or type 1H material for the surface. Thank you.

In regards to location of the proposed 2-2B catch basin in the right ditch line between the railroad tracks and SR 95 at station 602+83.17 28' RT; the proposed CB will infringe upon the RR's theoretical embankment line as per the "Specific Requirements of Consolidated Rail Corporation for Work on It's Right of Way". This infringement will require some type of sheeting to protect the railroad property as per the mentioned railroad specification. Does ODOT have approval from CSX for the contractor to excavate and place a drainage structure within their right of way or will the contractor need to acquire approval from the railroad? Should the cost for the protection of the railroad's property be included in the catch basin's bid item or will a Cofferdams, Cribbs and Sheeting item be added to the project.
