On sheet 7/60 of the drawings, it appears that plan note: Item 608 - Curb Ramps (with Detectable Warnings), and plan note: Item 608 - Detectable Warnings, As Per Plan conflict with each other. The second note says that "these installations shall occur where curb ramps are not warranted". Then it says, "Each installation shall be a wet set application into the proposed concrete". Which is it? If "no curb ramp is warranted", then why is there any proposed concrete? Did the designer really intend to use a surface mounted tactile warning mat? It appears that proposal Note 608 was intended to clarify the way Item 608 - Curb Ramps was supposed to be paid, but it has had the opposite effect. Is the curb removal and installation now included in the SF of curb ramp, and is the installation of the new curb supposed to be monolithic with the new ramp. That's the way we were instructed to build 110022.

No curb ramp is warranted as the walk will be the same elevation as the pavement it is approaching at the applicable location in the plans. The wet set is required for the detectable warning installation in the walk approach to the pavement so the concrete is paid for under the walk.
