Q3) PLEASE ADD AN ITEM FOR TEMPORARY JACKING OR CLARIFY THE AS PER PLAN NOTE FOR PORTION OF STRUCTURE REMOVED TO INCLUDE THE TEMPORARY JACKING.

Q4) PLAN NOTE UNDER MAINTAINING TRAFFIC STATES 'NO TIME EXTENSION WILL BE GIVEN DUE TO WEATHER-RELATED DELAYS'. THE CONTRACTOR CAN ONLY GUESS AT WEATHER DELAY. HOW IS IT REASONABLE TO EITHER ADD UN-NESSECARY MONEY TO THE JOB OR PENALIZE THE CONTRACTOR FOR SOMETHING COMPLETELY OUTSIDE OF HIS CONTROL? THE CONTRACTOR REQUEST TO HAVE THIS NOTE REMOVED FROM THE PLAN AND LET CMS 108.06 SUPERCEDE.
