We will bid this project with the assumption that these items DO NOT need to be on the QPL/Certified Supplier Approved List to incorporate them into the project since they are the only acceptable items in the plans. Please give a list of QPL/Certified Supplier listed items of work by addendum if our assumption is not correct.

1) On thie project in several locations there are retaining wall structures that appear to rest on the existing sidewalk in areas where the sidewalk is to be removed and replaced. What happens if the retaining wall suffers damage from the removal process and how do you place the new sidewalk to the proposed width in these areas?2) There is an area where the damage to the existing sidewalk is caused by tree roots from trees on private property. If the contractor removes these roots and the tree dies or suffers damage who is responsible?

A: The intent is to remove the walk as close to the face of the retaining wall as possible. The new walk will be placed against this removal line. A: The contractor will not be responsible for the health of any trees due to removal of roots within the right of way.

On the plan note of grounding and bonding the ground wire in the 3 wire system can this be used to bond the conduit or do you have to pull in a seperate wire to bound plus to ground the pull box lids do you use the same wire and go against the national electric code or are you going to pay for a ground rod at each pull box

The note shown on Sheet 64 of the plans states that "Both end of metallic conduit shall be bonded to the equipment grounding conductor" (Section 2,C). Also, "Metal pull box lids shall be bonded by attachment of the equipment grounding conductor to the frame diagonal as provided on HL-30.11" (Section 1,D). A separate wire is not required to be pulled to bond and ground rods are not required at the pull boxes.
