

WHO TO CALL CONSULTANT MEET & GREET

In May 2012 the Department and the American Council of Engineering Companies of Ohio (ACEC) worked jointly in developing the first ODOT/ACEC Partnering Conference to address potential issues between expectations of the Department and ACEC members. The 2019 Conference resulted in several action items for the Department with one of those being that ODOT would develop a “Who to Call” contact information list to assist Consultants in setting up Meet & Greets with the Department.

Having or not having a “Meet & Greet” with a District or Office is **not a requirement or criteria for selection**. These meetings are often requested by Consultants that have not done work with the District/Office and want to make the District familiar with their services and personnel they can provide.

As a reminder the District Consultants Committee consists of:

- District Deputy Director
- District Capital Program Administrator
- Rotating Member Based on Work Type – One of the Following:
 - District Design Engineer
 - District Planner / Planning Engineer
 - District Construction Engineer

Marketing meetings are an allowable communication with restrictions as identified in Volume 1 – Consultant Contract Administration Section 3.6.B.3.

This “Who to Call” list identifies one person from each District or Office that will be the single point of contact for Consultants desiring to schedule a Meet & Greet meeting.

When requesting an appointment, Consultants should communicate their purpose for the meeting, including:

- Projects of interest
- Technical services your firm provides
- Staff you want to introduce
- ODOT staff that you want to meet

This will facilitate scheduling, so ODOT can include the right people with the information desired. Recognize that Meet and Greets are a large commitment of time for both the Consultant and for the Department, please be respectful of this when scheduling. The Department will make every effort to accommodate each request but because of time constraints and other commitments may not be able to in the time frame desired.
