SUBJECT: Floodplain Statement of Findings
PROJECT: RIC-30-11.58 PID 98911

Floodplain Affected: Zone AE of Rocky Fork

Description of Project: The proposed project will take place along US 30 and Longview Avenue within the City of Mansfield and Madison Township, Richland County, Ohio. The project proposes to reconstruct the US 30 pavement and replace the bridges from the railroad bridge east of Bowman Road to east of Fifth Avenue, in Mansfield. The work includes replacing the mainline pavement, constructing a median barrier and widening the outside shoulders of US 30 to meet current design standards, repaving the existing SR 13 and SR 545 westbound interchanges; constructing a new SR 13/SR 545 westbound interchange between the existing SR 13 and SR 545 interchanges; and repairing and repaving East Longview Avenue between SR 13 and SR 545. Additional work includes cutting back rock faces along eastbound and westbound US 30 between SR 545 and Fifth Avenue, adding vandal protection to all bridges over US 30; providing lighting through the corridor; and replacing all project drainage structures and right of way fence. Additional permanent and temporary R/W is required to construct this project. Deep excavation and utility relocations will also be required during construction of this project. The project will require the removal of 4.98 acres of suitable wooded habitat for Indiana bats and Northern long-eared bats. Trees will be cut between October 1st and March 31st to protect these species during the summer roosting period. The project is federally, and state funded. Because of the nature of construction, a maintenance of traffic plan (MOT) will be utilized to maintain traffic always during construction. Cross overs will be utilized as part of the MOT to avoid closing US 30 during the two-year construction cycle. The construction start date is anticipated to be April 1, 2020. Based on the attached Flood Insurance Rate Map (FIRM), the project is in the regulated floodplain. Attached is the FIRM showing the floodplain boundary in relation to the proposed project.

Why must this project be in the Floodplain?

An analysis of improvements that avoid the floodplain indicates that they are not practicable because the improvements would result in substantial adverse community impacts to adjacent homes, businesses, or other improved properties. These improvements will also substantially increase project costs, result in unique

engineering, traffic, maintenance, safety problems, substantial social, economic, or environmental impacts, and will not meet the identified needs of the project.

What alternative sites were considered, if any?

Three alternative alignments were considered. None of the alternatives eliminated the need to be in the floodplain of Rocky Fork.

Were any mitigation measures utilized on this project? If so, please describe.

Yes. During the development of this project, ODOT considered design elements that would reduce the construction footprint within the floodplain of Rocky Fork to the maximum extent possible.

To the best of my knowledge, this project has complied with all applicable Local, State, and Federal Floodplain protection standards.
